A consistent focus on local capacity strengthening helps prepare local organizations to receive transition grants and move beyond external assistance.

As the emergency phase of the COVID-19 pandemic subsides in many settings, LHSS remains at the forefront of efforts to advance thinking on resilience, preparedness, and epidemic prevention.



#### Advancing Equitable Access to Essential Health Services

#### Facilitating Monitoring, Evaluation, and Learning


